SITETODAY MARKETING PACKAGE DEVELOPMENT AGREEMENT

This Web Site Development Agreement is made by and between Creat LLC ("Web Designer"), with its principal place of business at 723 S. Main Street #305 West Bend, WI 53095 and _____ ("Customer") with its principal place of business in _____. Customer desires to retain Web Designer to develop the World Wide Web site (the "Web Site") for Customer as described below. Web Designer desires to undertake the development of the Web Site and agrees to do so under the terms and conditions set forth in this Agreement; as follows :

Section 1. SITETODAY PACKAGE AND Work Plan.

SiteToday Marketing Package includes custom web design, hosting , domain registration , changes to content in website, and design time for marketing materials. Web designer will develop initial design based on pre-design interview sheet, meetings, and telephone discussions. Web designer will provide services for client for as long as they are a current on their account.

Section 2 Payment Schedule.

Before start of the project, customer will remit payment information for an ACH transaction out of a checking account or automatic payment from a credit card in the amount of \$69.99 which is equal to 1/18 of the total contracted payments. The customer will then make 17 additional payments of \$69.99 which will be drawn on the date of each month that the first payment was made starting 9/15/2010 and ending 2/15/2012 . After the 18 month, the account will continue on a month to month basis. Client may cancel in writing after the initial 18 months. Failure to make payment by the aforementioned date will result in a \$100.00 penalty. Continued delinquency may also result in temporary and/or permanent discontinuation of services provided without refund . If client fails to make payments without arrangements Creat LLC has the right to display any information/advertising on customers website.

Section 3. Rights to Work Product.

Creat LLC owns the rights to all design and layout of website and marketing materials designed for the duration of the 18 month service agreement. Customer owns rights to all content and information provided in the creation of website and marketing materials after the 18 month service agreement has been fulfilled . In the case of early termination, customer will own rights to design and content after a \$500 termination fee is paid and after the 18 month term has expired .

Section 4. Training.

Web Designer shall provide limited telephone training in the use of the Web Site as long as account is current. Limited support via phone or e-mail will be available to Customer for the term of the contract. Web Designer is not responsible to for providing software and/or technology to Customer. All CMS,content management system, customers will be put on a platform of the web designers choice.

Section 5. Representations and Warranties.

Customer takes full responsibility for any information represented on any marketing materials and website. Customer warrants that all content is original and does not infringe on any copyright.

Section 6. Confidentiality.

Any information obtained by Creat LLC will remain confidential and not be shared with any competition and remain between customer and Creat LLC.

Section 7. Term of Agreement.

This Agreement commences on the date it is executed and shall continue until full performance by both parties, or until earlier terminated by one party under the terms of this Agreement.

Section 8. Termination of Agreement.

This Agreement may be terminated by the Customer after the 18 months with a certified letter sent 30 days in advance to PO BOX 111 , Menomonee Falls, WI 53051 . Termination before the 18 month agreemen1 will result in an \$500 early termination fee and does not require Creat LLC to provide any information to customer until 30 days after all fees are paid in full .

Section 9. Location of Web Site.

Web Designer will host site for terms of contract unless requested by client. Creat may use hosting service of their choosing. Web designer currently uses a virus protected dedicated server, but may switch locations without customer consent at any time. Customer is guaranteed a 99.5% uptime. Any downtime after the .5% will be prorated and refunded at \$0.0807 per hour.

Section 10. General Provisions.
